**THE AMERICAN KENNEL CLUB (AKC) CERTIFICATION**

Permission has been granted by the AKC for the holding of these events under AKC Rules and Regulations. *Gina M. DiNardo, Executive Secretary*

### Entry fees:

\$37 for the first entry of each dog  
\$33 for each additional entry of the same dog in the same trial.  
Fees include all AKC event service and recording fees.

Jump Height is required for all classes with jumps.

Classes with jumps will run in **ascending jump height order**, beginning with the lowest jump in all trials. Exceptions to jump height running order may be made for handlers with multiple entries.

Judges are not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when its class is called.

Bitches in season are not permitted to compete in obedience trials. The club will refund entry fees for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated, signed letter on official business letterhead from veterinarian stating the reason the dog cannot compete.

**Transfers:** A transfer request from one obedience or rally class to another will be accepted prior to and after the trial closing date. Such requests should be sent through regular mail or email, or presented to the trial secretary at least 30 minutes prior to the start of the trial, and should include the following information: Owner's name, dog's registered name, dog's registration number, jump height (if any), class moving from, class moving to.

Transfers made after the closing date will be judged at the end of each class. The Trial Secretary must be notified no later than 30 minutes prior to the start of the first class in the trial.

No food or beverages available on site. Many fast food restaurants are available nearby.

**Parking:** All vehicles must be parked nose-in — not parallel with edges of parking area.

There will be no indoor crating for exhibitors in the Top Dog building. Indoor exhibitor crating will be available in the Top Dog Day Care.

**Tarps/sheets/towels must be placed under all crates, no exceptions.**

Reminder to all competitors — read your final judging schedule for updated COVID rules. We will be following the latest information and will continue to adapt our policies as needed to stay in compliance.
