Each rally trial is a separate event. For example, entries in Rally Novice B in Trial 1 and Rally Novice B in Trial 2 will result in an entry fee of \$70.00, NOT \$67.00.

"Dog" means either sex.

## Transfers

A transfer request from one Obedience or Rally class to another will be accepted prior to and after the trial closing date. Such requests should be sent through regular mail or e-mail, or presented to the Trial Secretary at least 30 minutes prior to the start of the trial, and should include the following information: Owner's name, dog's registered name, dog's registration #, jump height (if any), class moving from, class moving to.

Transfers made after the closing date will be judged at the end of each class.

## ENTRY LIMITS

Entries will close as follows:

**RALLY:** Entries will close when 50 entries for each trial has been reached.

**OBEDIENCE:** Entries will close when 8 hours of judging each trial has been reached.

A WAIT LIST will be established for these trials to fill openings created by entries that are withdrawn prior to the closing day. The full entry fee will be refunded to an entrant whose entry is replaced by a wait-listed entry.

## NOTICE TO EXHIBITORS

**There will be no indoor crating at these trials. Car crating only!**

**FOOD CONCESSIONS** will NOT be for sale at this trial, so please bring your own food and beverages. There are a number of fast food restaurants and eateries close by the show site on Rt. 206.

**CONSULT JUDGING PROGRAM** for time of judging.

**REFUND CHECKS** are void after 180 days and will NOT be re-issued.

**THE TRIAL COMMITTEE** will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this trial. **THE K-9 OBEDIENCE TRAINING CLUB OF ESSEX COUNTY, NJ, INC. **THERE WILL NOT BE AN OFFICIAL PHOTOGRAPHER** available at this trial.

**FREE ADMISSION & PARKING.** Absolutely no parking is allowed on the street.

**ACKNOWLEDGEMENT OF ENTRIES** will be made as soon as practicable. **SHOULD SUCH ACKNOWLEDGMENT NOT BE RECEIVED BY THE EXHIBITOR** within a reasonable time, please notify the Trial Secretary at [trekker375@aol.com](mailto:trekker375@aol.com).

**ENTRY FEES FOR BITCHES IN SEASON** after entries close will be refunded only when exhibitor provides a letter from a veterinarian on business letterhead. It can be emailed or sent via US mail to the Trial Secretary or presented to the Trial Secretary at least 30 minutes prior to the start of judging the first class.

**DO NOT LEAVE DOGS IN CLOSED VEHICLES!!!!!!** If any dog seems to be suffering from extreme temperatures or is confined without proper supervision, the authorities will be notified to handle the situation. Violators will be reported to the Trial Committee and/or the AKC for disciplinary action. **RETURNED CHECKS** do not constitute a valid entry fee. A \$25.00 collection fee will be added to the amount of each returned check. **CREDIT CARD PAYMENTS** are not accepted.

**ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS** and copies of AKC entry forms without the agreement and rules are **NOT ACCEPTABLE**. **UNSIGNED ENTRIES** will not be processed.

**NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**ENTRY FEES** will not be refunded if a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by the action of the Trial Committee. If, because of riots, civil disturbance, or other acts beyond the control of the management, it is impossible to open or to complete the trial, no refund of entry fees will be made.

**EXTREME WEATHER CONDITIONS** such as, but not limited to, snowstorms, hurricanes, lightning, or extreme heat must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors, and spectators is of paramount importance and in the event it is necessary to stop or cancel the trial before completion, no refund of entry fees will be made.
